The regular meeting of the Osceola Township Water Board was called to order by Supervisor Karpiak on May 13, 2015, at 6:07 pm in the Osceola Township Meeting room. Board members present were Steve Karpiak, Judy Odgers, and Don Wareham. Absent were Mary Ringler and Aaron Janke.

Motion by Karpiak, supported by Wareham to accept the minutes of the April meeting. AVIF
Motion by Odgers, supported by Wareham to approve the financial reports. AVIF
Motion by Wareham, supported by Karpiak for payment of the bills totaling \$15585.83 of which \$10134.30 are back Julio Contracting bills. Unfinished Business:

- a. Operator's Report: Mattfolk submitted an oral report. He has been hanging red tags, marking Miss Digs, and filling work orders. Pumpage report shows water pumped vs billed is still high. Water test results are satisfactory. The Dollar Bay shut off list has \$11937.03 in delinquent payments. Shut off of water service will begin on May 20, 2015 if payment is not made in full.
- b. Repairs and Leaks: Repaired a water main on Fir Avenue going to Red Cole's house and advised Mr. Cole that his service line needs to be replaced. Mattfolk replaced a meter in Tamarack City at the Biskner house.

New Business:

- a. Court appearance: Karpiak and Mattfolk appeared in court for the small claims filed against the township by Deb Lajimodiere for payment of her frozen water line costs. Judge Wisti informed her that she could not sue a municipality in the State of Michigan and dismissed the case.
- b. Storage building bids: Dick Supina, TES, recommended the township accept the bid from Reed Construction for \$34,500.00 to build a storage building by the pump house in Dollar Bay. The Board decided to accept Reeds bid but will table until the June meeting, the motion was made by Kapiak, supported by Wareham. AVIF.

c. Water meters: Mattfolk purchased meters with the approval of Odgers at \$150.00 each and they come in cases of 8.
